Clarification of News Report

We write in reply to PSE's letter dated July 30, 2015 seeking clarification and/or confirmation of the news article entitled "5 vie for Davao Sasa Modernization Project" posted in the Malaya Business Insight (Internet Edition) on July 30, 2015. The article reported in part that:

"Five groups, including International Container Terminal Services Inc. (ICTSI), have submitted pre-qualification documents for the P18.99-billion Davao Sasa modernization project.

ICTSI has not submitted any bid at this stage. The terms of reference on the project bid has not yet been released by DOTC and access to any documentation on the tender, whether feasible or not, will only be available to those who have filed for pre-qualification.

As part of its normal course of business, ICTSI constantly reviews and explores privatization processes in the Philippines and around the world. ICTSI shall make proper disclosure on any of these opportunities as and when appropriate.
