Clarification of News Report

We write in reply to PSE's letter dated February 2, 2018 seeking clarification and/or confirmation of a Biz Buzz column entitled "Razon wins again" published in the February 2, 2018 issue of the Philippine Daily Inquirer. The article reported in part that:

"Any doubt that ports tycoon Enrique Razon Jr. has once more won the war for control of the country's main shipping port should now be put to rest.

To recall, Razon-who owns International Container Terminal Services Inc.-was briefly engaged in a battle for Manila's port against the Harbour Centre group of businessman Michael Romero.

. . . .

In any case, it's now clear that Razon has won another round in the battle for control of the ports which flares up every few years or so.

That's because Biz Buzz heard that the officials of Harbour Centre (which operates the North Harbor port, as opposed to Razon's South Harbor contract) now report to a certain Christian Gonzales.

Christian Gonzales is, of course, the nephew of Razon who is now the de facto heir apparent of the tycoon in his port operations.

'As of late last year, the North Harbor people have been taking orders from Gonzales,' one industry source said. 'That means Razon is now in control of the firm.'

Expect ICTSI or one of Razon's firms to announce a formal buy-in into Harbour Centre in the next few weeks. . . .

. . . ."

In reply, ICTSI wishes to state that it owns 34.83% of the shares of Manila North Harbor Port, Inc. ("MNHPI") which ICTSI

acquired last year, as previously disclosed to the PSE on September 22, 2017 and October 30, 2017. ICTSI does not have any ownership interest in Harbour Centre Port Terminal, Inc..

We trust that you find the foregoing clarification sufficient and in order.
