Item 9 – Other Events

International Container Terminal Services, Inc. (ICTSI) will be reporting a 14 percent increase in consolidated gross revenues in the first half of 2019. First half revenues from port operations increased from US\$661.8 million in 2018 to US\$751.8 million in 2019 mainly due to volume growth; tariff adjustments for certain services at multiple terminals; new contracts with shipping lines and services; continuing ramp-up at ICTSI's operations in Melbourne, Australia and Manzanillo, Mexico; and the contribution from the Company's new terminals in Lae and Motukea in Papua New Guinea. For the second quarter of 2019, gross revenues increased nine percent from US\$336.4 million to US\$368.0 million.

This disclosure is in accordance with Section 4.4 of the Revised Disclosure Rules of the Philippine Stock Exchange effective 2003.
