International Container Terminal Services, Inc. (ICTSI) will be reporting a 16 percent increase in consolidated gross revenues in the first quarter of 2021. First quarter revenues from port operations increased from US\$375.8 million in 2020 to US\$435.6 million in 2021 mainly due to volume growth, favorable container mix, tariff adjustments at certain terminals, new contracts with shipping lines and services, and increased storage and ancillary services particularly in the Americas segment; partially tapered by decline in trade activities at certain terminals primarily due to the impact of COVID-19 pandemic.

This disclosure is in accordance with Section 4.4 of the Revised Disclosure Rules of the Philippine Stock Exchange effective 2003.
