International Container Terminal Services, Inc.'s (ICTSI) consolidated gross revenues in the first nine months of 2021 increased by 24 percent to US\$1.365 billion from US\$1.104 billion in 2020 mainly due to higher volume; favorable container mix; tariff adjustments at certain terminals; new contracts with shipping lines and services; higher revenues from ancillary services; contribution of new terminals; and net favorable impact of foreign exchange at certain terminals; partially tapered by decline in trade activities at certain terminals primarily due to the impact of COVID-19 pandemic. For the third quarter of 2021, gross revenues increased 27 percent from US\$379.3 million to US\$482.4 million.

This disclosure is in accordance with Section 4.4 of the Revised Disclosure Rules of the Philippine Stock Exchange effective 2003.
